Description of Services and Hours of Operation

During the term of your membership in the Program, you will be entitled to receive the following benefits:

VIP Membership Benefits.

On the last day of each calendar month during your membership, your credit card will be charged the sum of \$150.00 (plus applicable sales tax). That charge will entitle you to receive Signature Facial AND one Signature Massage during the following calendar month.
- A discount of 10% off all facial retail purchases.
- Enjoy Gold/VIP member pricing
- A \$100.00 Spa Gift Card on your birthday.

- Since the spa is designed for an adult experience, no children are allowed.
- We ask that you leave valuable jewelry at home. We are not responsible for lost items.
- We ask that you please disclose to our therapists any physical ailments, skin allergies or disabilities.
- Pregnant women may not receive a massage in their first trimester.
- Return policy-unused merchandise may be returned within 14 days for store credit only.
- Refusal of service-we retain the right to refuse service to anyone. Sexual advance, comments or innuendos toward our staff will result in immediate termination of treatment.
